ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 S.J.P.V.V. Peetha, Davangere District, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri saila College of Education, P.B. Road, Harihar-577601, Davanageri District, Karnataka for M.Ed course of one year duration with an annual intake of 25 (Twenty five) Students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Sri saila College of Education, P.B. Road, Harihar-577601, Davanageri District, Karnataka for conducting M.Ed course of one year duration with an annual intake of 25 (Twenty five) students under clause 7(12) of Regulations dated 13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - The institution will ensure that One Reader and Three Lecturers faculty members duly approved by the affiliating University are in position for an intake of 25 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- The institution shall make admissions only after it obtains affiliation from the examining body.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
- If the institution contravenes any of the above conditions or any of the provisions
 of the NCTE Act, Rules, Regulations and Orders made or issued there under, the
 Regional Committee shall withdraw the recognition under the provisions of
 Section 17(1) of the NCTE Act

WHEREAS, Sri Saila College of Education, Harihar -577601, Davangere District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for offering B.Ed course of two year duration under Section 14(1) of the NCTE Act, 1993. Recognition order was issued to the institution on 10.07.1996.

AND WHEREAS, a letter was issued to the institution regarding notification of new Regulation 2014 seeking consent on their willingness for fulfilling the revised Norms and Standards on 31.05.2015 and the institution has not submitted the affidavit. The institution submitted affidavit on 12.6.2015 for coming under new Regulations. Revised recognition order was issued to the institution vide letter dated 03.07.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students each of two basic units from the academic session 2015-16 subject to fulfillment of the conditions mentioned therein before 31.10.2015. Corrigendum was issued to the institution on 11.08.2015 for an intake of 50 students

AND WHEREAS, the SRC in its 359th meeting held during 17th -18th May, 2018 considered the non submission of SCN reply and decided to withdraw recognition granted to the Institution. Accordingly, the recognition of Sri Saila College of Education, Harihar -577601, Davangere District, Karnataka for B.Ed programme was withdrawn w.e.f. 2018-19 vide order No. F.SRO/APSO3398/B.Ed/KA/2018-19/97419 dated 23.05.2018.

AND WHEREAS, aggrieved by the withdrawal order, the institution preferred an appeal to NCTE-Hqrs. The Appellate Authority in its order dated 24.12.2018 reversed SRC's order dated 23.05.2018 with the direction to SRC the Council hereby remands back the case of Sri Saila College of Education, Vageesha Nagar, Harihar, Karnataka to the SRC, NCTE, for necessary action as indicated in the appeal orders.

AND WHEREAS, the SRC considered the matter in its 370th meeting held during 07th – 08th February, 2019 and its 372nd meeting held on 3rd March, 2019. The SRC in its 373nd meeting held on 26th -27th March, 2019 also decided to issue SCN on certain points. Accordingly per the decision of SRC, a Show Cause Notice was issued to the institution on 01.04.2019. The institution has submitted reply on 12.04.2019 & 09.05.2019.
