I am directed to state that the Principal, S.J.V.P. College of Education, Harihar, requested this University in letter No.A/118/72 dated 8-2-72, for the grant of fresh affiliation to the above College from the year 1972-73.

The Affiliation Commission in Education, constituted by the University Syndicate inspected the college on 22-8-72 and gave its report.

Since the report on the inspection of several colleges were under process the Academic Council at its meeting held on 2-6-1972 by a resolution empowered the Vice-Chancellor to take appropriate action on the reports of the Affiliation Commission and make recommendation to Government. The Syndicate at its meeting held on 22-7-72 endorsed the resolution of the Academic Council.

The Vice-Chancellor after perusing the recommendations of the Affiliation Commission endorses the same.

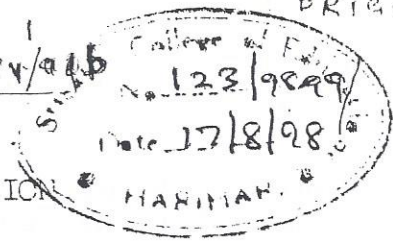

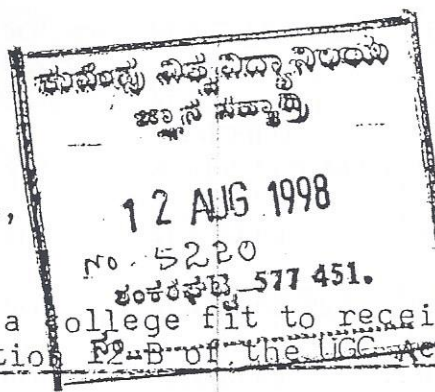
